

NOTICE TO BOUNTIFUL CITY UTILITY CUSTOMERS

Transfer from Light & Power Fund to the General Fund

State law requires that the City provide an annual disclosure on amounts transferred from utility Enterprise Funds to the General Fund. Historically, Bountiful has budgeted for the transfer of 10% of Electric Metered Sales (\$2,490,000) from the Light & Power Fund to the General Fund. This year, this transfer represents 7.9% of total budgeted expenditures in the Light & Power Fund.

These transferred funds are used each year to help cover the costs of important services like police, street maintenance and snow removal, fire and emergency medical services, parks, and similar City services. The utility transfer helps keep property taxes in Bountiful low. Viewed in another way, these transfers are a "dividend" to Bountiful taxpayers as the result of the taxpayers' original investment in the City's power infrastructure. If City utility services were provided by private utility customers, these dividends would instead be paid to investor-owners; because Bountiful taxpayers are the investor-owners, these dividends are used to offset what otherwise would be a significant increase in property tax rates. The transfers also provide a means for reimbursement of the General Fund for services provided to non-property tax paying groups such as non-profit organizations, churches, and governmental entities.




The Administrative Services Reimbursement is made for the purpose of reimbursing the General Fund of the City for services provided to the Enterprise Funds. These services include such things as payroll/employee benefits, accounting, budgeting, legal, insurance work, billing/customer service and other professional services provided by department staff of the General Fund to the Enterprise Funds of the City.

Light & Power Fund Transfer to General Fund



This annual transfer of funds is made each year from the Light & Power Fund to the General Fund based on 10% of metered sales. The transfer helps cover the costs of important services like police, street maintenance and snow removal, fire and emergency medical services, parks, and similar City services. The utility transfer helps keep property taxes in Bountiful low and represents just 7.9% of the total budgeted expenses of the Light & Power Fund in Fiscal Year 2019-2020.

Landfill Fund Transfer to Recycling Fund
