Campaign Financial Statement Amendments to 28 Day Report and General Election Report for Bountiful City Council Candidate Beth Child

According to Utah Municipal Code 10-3-208, subsection (14) (a) and (b), if a candidate for municipal office has made an error in reporting, they may rectify the situation in an amended report.

The code says, "a candidate who timely files each campaign finance statement required under Subsection (4) or (5) is not disqualified if: (a) the statement details accurately and completely the information required under Subsection (7) except for "inadvertent omissions or insignificant errors or inaccuracies; and (b) the omissions, errors, or inaccuracies are corrected in an amended report or in the next scheduled report."

 On Campaign Financial Statement for Candidate Beth Child submitted October 6, 2025, also known as the 28 Day Report, I made an inadvertent calculation error resulting in an inaccuracy of \$100 in line 6: Balance at the end of the reporting period.

I did not add the aggregate contributions of \$50 or less (contributions which totaled \$100) to the contribution total before subtracting the total campaign expenses. This resulted in my reported figure of \$5,947.66 rather than the correct figure of \$6,047.66 as the remaining balance in my campaign account.

Also on Campaign Financial Statement submitted 10/6/25, I inadvertently omitted designating my personal campaign contribution as a "loan." I have amended this.

2. On Campaign Financial Statement for Candidate Beth Child submitted October 28, 2025, also known as the General Election Report, because of the \$100 reporting error in the first report, I have an inaccuracy in line 3. Contribution balance from previous reporting period. That number should be the aforementioned figure of \$6,047.66. Line 4. Contribution total should be \$6,372.66. Line 6. Balance at the end of the reporting period should be \$3,269.36. All forms have been amended and resubmitted with the correct figures.
