### **Background**

The governing body, acting as the Board of Canvassers, is required by State law UCA 20A-4-301(2)(b)(i) to officially canvass and adopt the election returns. This meeting must occur no earlier than seven days and no later than fourteen days after the election. The canvass formally verifies the completeness and accuracy of the vote count, thereby officially certifying the results. Per contract, the processing and counting of all ballots for the Municipal General Election were conducted by the Davis County Clerk/Auditor's Office.
