## **Concept and Background**

Trails, parks, and other recreational facilities, dramatically effect the quality of life within a community. A good recreation network not only improves the quality of life for current residents, but is an important economic tool for attracting and retaining businesses.

The 2009 Recreation & Trails Master Plan does not directly address existing parks or improvements to existing parks because those items are accounted for in the Bountiful City Capital Improvements Plan which is updated yearly. Rather, this Plan will primarily address future acquisitions and/or the development of new parks and trails.

## Issues, Goals, and Policies

**Issue:** There are not sufficient alternative forms of trans-

portation within the City.

**Goal:** Increase bicycle routes and jogging trails by 50% within the next 10 years.

Action: Allocate approximately \$10,000 in

Budget Year 2011 to study this issue and develop a plan.

Issue:

The Lion's Club shooting range is an important service for residents of the community. However, it is an undesirable use in a residential area. Several of the existing skeet traps have been closed due to encroaching residential development. There is no sanitary sewer or culinary water serving the site, and there is no space to expand in the future.

Goal:

Develop a contingency plan so that in the future the gun club could be relocated to a site where the negative impacts of a shooting range can be mitigated and where all public utilities are available.


**Action:** City officials should meet with

representatives of the Lions's Club and other shooting organizations to determine the criteria for a shooting

range.

Action:

The City and/or Redevelopment Agency should set aside approximately fifty hours to work on this proposal.



**Issue:** New development has restricted and/or eliminated access to public lands located in the mountains

above the City.

**Goal:** Identify and preserve existing accesses



Goal: Substantially clean up/mitigate the major fire hazards by fall of 2010.

> Work with Metro Fire and Davis Action: County to develop an ordinance for property maintenance and fire restrictions in high risk areas that



> Aerial Photo and Map of Private Property within the Unimproved Portion of North Canyon




roadway that runs across private property along the bottom of the canyon. Furthermore, at some point a section of the canyon was subdivided into many small parcels that have no access to public utilities and that are not legally developable under current Davis County Ordinances.

Goal: Resolve the access and property ownership issues within the next 3 years.

Work with Trust for Public Lands, the Forest Service, Davis County, the State of Utah, private property owners, and other interested parties to explore the feasibility of consolidating the smaller parcels into one ownership and/or establishing a future use plan for those areas that are developable.

**Issue:** There is a growing demand for urban trails within the community.

Goal: Establish an interconnecting urban trail system that links pedestrian friendly uses within the City such as parks, schools, regional trails, mass transit, Downtown, etc.

Action: Draft and adopt an urban trails map as part of the 2009 Recreation &

Trails Master Plan.

**Action:** Create a 10 year plan for the implementation of the urban trails

map

**Issue:** There is a very limited amount of funds available

for trails.

**Goal:** Generate new revenue to pay for the acquisition of trails

Action: Study the possibility of implementing a parks impact fee to help pay for new trails and parks

**Action:** Apply for trails grants

**Action:** Work with local businesses, service

organizations, and other groups to raise funds and provide labor

**Issue:** Trails lack signage and other basic improvements.

**Goal:** Have a trail map posted at every trailhead, and post trail markers every 1/8 mile

Action: Establish a 5 year plan for funding

and installing trail signs on all trails within the City's jurisdiction.

**Goal:** Bring all trails up to a minimum standard of improvement

Action: Establish a 5 year plan to adopt

and implement a minimum trail improvement standard for all approved trails within the City's

jurisdiction.

Issue: Many existing user trails are located on private property and State Law does not allow the use of eminent domain to acquire trails and government can no longer require developers to install trails without compensating the developers for the exaction.

**Goal:** Generate new revenue to pay for the acquisition of trails

Action: Study the possibility of

implementing a parks impact fee to help pay for new trails and parks

**Action:** Apply for trails grants

Issue:

The demand for access to public trails and public lands is increasing, and Bountiful City has installed a parking lot and restrooms at the mouth of Holbrook Canyon, however, a substantial portion of the Canyon is still held in private ownership.

**Goal:** Acquire fee title and/or a trail easement for the entire length of Holbrook Canyon.


Action: Negotiate with property owners in Holbrook Canyon to secure trail easements and/or to acquire prop-

erty ownership.

**Action:** Apply for grant monies to facilitate

easement and/or property acquisi-

tion
