BUSINESS NAME:	Name Registration Certificate
SITE PLAN:	Site Plan and Letter of Permission from property owner.
INSURANCE:	Liability Insurance form shall be in the sum not less than \$2,000,000/\$2,000,000 for bodily injury and /or property damage.
INSPECTION:	Fire Inspection Approval with South Davis Metro Fire Agency
