



Please be advised that the Bountiful City Planning Commission will hold a public hearing on Tuesday, August 14, 2018, at 6:30 P.M. or as soon thereafter as the matter can be heard, in the Planning Conference Room, Bountiful City Hall, 790 South 100 East, Bountiful, Utah. The purpose of the hearing is to review a request for a variance to Section 14-4-105 J.2.b. in order to allow for the construction of a detached garage. The Code limits the total area of all accessory structures on a lot or parcel to 15% of the parcel area. With the proposed garage, the area of accessory structures will total approximately 17% of the lot area. The variance requested is for the property addressed 146 W 100 South, Jan Rawlins, applicant.
