This Indenture, Made this 23<sup>rd</sup> day of Sept. A.D. 1911 by and between School District Number Two of Davis County, State of Utah, by Irvin F. Fisher, Frank B. Smedley and Truman H. Barlow, the duly elected, qualified and acting Trustees of said School District, parties of the first part and The Board of Education of the Davis County School District of Davis County, State of Utah, party of the second part.

Witnesseth: That whereas the Board of County Commissioners of Davis County, State of Utah, by a resolution, duly pass at a regular session of said Board, held on the 3<sup>rd</sup> day of July A.D. 1911, did consolidate all of the existing School District of Davis County, State of Utah, into a School District of the First Class to be known and designated as the Davis County School District of Davis County, State of Utah, and of which said School District Number Two forms a part.

Now Therefore in consideration of the premises and the sum of One (\$1.00) Dollar, the receipt of which is hereby acknowledged, the said parties of the first part as trustees of the said School District No. 2, do by these presents grant, bargain, sell, and convey unto the said party of the second part and their successors [sic] in office for the use of the district schools of said district, the following described tracts of land in Davis County, State of Utah, to-wit:

Beginning at a point 63.25 rods South and 152 rods East from the Northwest corner of Lot 6, Block 37 North Mill Creek Plat Survey, Davis County, Utah, running thence East 14 2/3 rods; thence North 6 rods; thence West 12.416 rods; more or less to the East line of Highway No. 2; Davis County Road Survey; thence Southwesterly along the East line of said Highway 6.50 rods, more or less to the point of beginning, containing 84.36 square rods, more or less within the limits of the SE 14 (?) of Section 30 Township 2 North Range East, Salt Lake Meridian, U.S. Survey.
