



# SNAP/EBT INFO BOUNTIFUL FARMERS MARKET

## When and where is the Farmers Market?

- **Location:** Bountiful Town Square
- **Address:** 75 E 200 S Bountiful, UT
- **Dates:** Every Thursday June 25 - October 15
- **Hours:** 4pm - 8pm all season

## How do I use SNAP at the Farmers Market?

1. Bring your SNAP/EBT card to the Bountiful Farmers Market info booth at the Northwest corner of the market. Tell the staff how much of your benefits you would like to spend.
2. Market staff will run your card on an EBT enabled POS device, and you will receive tokens of an equivalent value. Additionally, you will receive Double Up Food Bucks tokens. These are matched dollar for dollar, up to \$20 per market day.
3. You may spend SNAP tokens to purchase eligible food items from vendors.

## What food items are eligible for SNAP?

You can use SNAP tokens to purchase food that you prepare and eat at home. This includes foods such as:

- Bread
- Meat and Fish
- Vegetables and Fruits
- Plants and Seeds that Grow Food

SNAP cannot be used to purchase the following:

- Alcoholic Beverages
- Non-food Items
- Ready to Eat Food Items, including Hot Food
- Soft Drinks

## Which vendors accept SNAP?

Our vendor line up changes week to week. Look for an up-to-date list at the info booth every week. Each vendor that takes SNAP will have a visible sign stating: SNAP accepted here.

## Can I save my tokens for another date?

Yes, SNAP tokens do not have an expiration date and do not need to be spent the day you receive them. There is no cap on how many tokens you can save.

## Can I use my tokens at another Farmers Market?

You CANNOT use Bountiful Farmers Market SNAP tokens at any other farmers market. They can be used as payment only at the Bountiful Farmers Market for eligible food items. You also CANNOT use other farmers market's SNAP tokens at the Bountiful Farmers Market.

You CAN use Double Up Food Bucks and Produce Rx tokens at any farmers market in Utah that participates in these programs, regardless of where you received them.

## Can I apply for SNAP at the Farmers Market?

No. We do not accept or help with applications for SNAP. Visit the [Department of Workforce Services](#) for more information on eligibility and how to apply.

## Can I exchange SNAP tokens for cash?

No. Market staff and vendors will not accept SNAP tokens in exchange for cash. Buying or selling SNAP benefits is a federal crime punishable by fines and/or jail time.
